Detroit Library Commission Special Meeting May 25, 2012

The Commission was prepared to adopt this budget at the May 8, 2012 Special Meeting. (City Council adopted its budget Thursday, May 24, 2012)

Adoption of the 2012/2013 Annual Budget – Action Item

President Kinloch asked if there were any changes in the budget since it was last discussed. Mr. Cromer said not to the budget, but the write-up for the budget would have to be changed. Due to some union issues, the sentence that reads "There is no salary step or merit increases and vacant positions are budgeted at \$1" has to be removed from the write-up. With this modification, the Committee of the Whole ratified the 2012/2012 Annual Budget. This item will be approved at a Special Meeting of the Commission sometime in the future. (Note: Commissioner Jackson suggested that

perhaps the Special Meeting could take place following the Audit Committee Mtg. in June).

President Kinloch asked if anyone the audience had questions.

Several staff members wanted to know if there was anything that could be done about Commissioners not attending the meetings. There is nothing in the *Commission Rules and Regulations* that addresses this issue. President Kinloch said basically there is nothing that can be done about this. However, he will continue to reach out to the Commissioners and hopefully have a quorum at a future meeting.

<u>Sandra Hines</u> - If there are members of the Detroit Library Commission that disagree with some of the actions taken they should come and explain their disagreements. If Mrs. Mondowney thinks she is being treated unfairly, then she should come and make her case – tell the public what she has done since becoming the Director of the Library.

<u>Valerie Glenn</u> - Said that she has had conversation with Commission members that have not been attending meetings when she sees them in the community. It is her understanding that they have no intention of returning to Commission meetings until they get their way.
